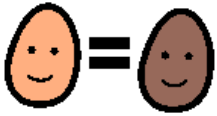


Equality and diversity at school and college

The Equality Act says everyone must be treated fairly.

The Equality Act says we should help people be kind to each other.

The Equality Act says no one should be treated badly.



Some groups of people are more looked after by the Equality Act.



This is because they have sometimes been treated wrongly.



These groups of people are called the protected groups.

Protected means they are looked after.

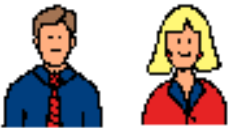
There are 9 protected groups.



The 9 protected groups in the Equality Act



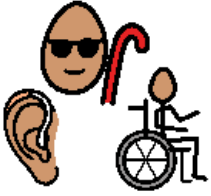
Race or Ethnicity this is to do with where people come from and might include the colour of their skin.



Your sex. This means whether you are female, male or intersex.



Gender reassignment this is a person means proposing to undergo, undergoing or having undergone a process to reassign your sex. For example, someone was born a woman but feels that he is really a man and decides to live as a man.



Disability this is a condition to do with somebody's body or mind that can limit what they can do in some way.



Religion or belief this is a person who believes in a god or gods and does activities to do with this.



Age this is how young or old a person is.



Sexual orientation is who a person is attracted romantically or sexually attracted to.

For example,

A heterosexual woman is attracted to a man.

A lesbian woman is attracted to another woman.

A gay man is attracted to another man.

A bisexual person is attracted to both men and women.



Pregnancy and Maternity

Pregnancy this is a woman who is growing a baby inside her.

Maternity this means before and after a woman has had her baby.



Marriage and Civil Partnerships this is two people in a relationship who have had a ceremony to make their relationship official.

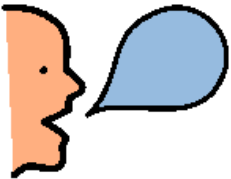
Any person might be in one or more of the protected groups.



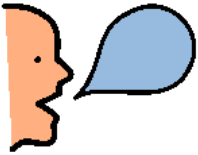

Staff have rights when they come to work at school and college.

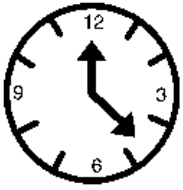
Staff rights are

Responsibilities

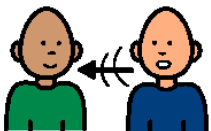


Responsibilities means doing the things you are supposed to do.

Students and staff must



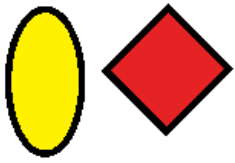
Show everyone respect.

Tell staff if something is not fair



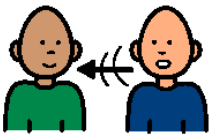
Respect how everyone is different.

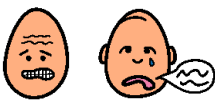


What to do if there is a problem
